Only shortlisted candidates shall be called for attending the Walk-in Interview.
4. Applications received after the last date or incomplete applications shall be summarily rejected without assigning any reason thereof.
5. The authority reserves the right to shortlist candidates for Walk-in Interview in the ratio of 1:5 based on eligibility criteria, academic qualification, relevant experience and scrutiny of applications received.
6. Mere fulfillment of minimum eligibility criteria shall not entitle a candidate to be called for the Walk-in Interview.
7. The list of shortlisted candidates along with the date, time and venue of Walk-in Interview shall be notified separately through official website/notice board/email communication.
8. Candidates appearing in the Walk-in Interview must produce all original documents/testimonials for verification at the time of interview, failing which candidature may be cancelled.
9. No TA/DA shall be admissible for appearing in the Walk-in Interview.
